## Introduction to IMPEL

The European Union Network for the Implementation and Enforcement of Environmental Law (IMPEL) is an international non-profit association of the environmental authorities of the EU Member States, acceding and candidate countries of the European Union and EEA countries. The association is registered in Belgium and its legal seat is in Brussels, Belgium.

IMPEL was set up in 1992 as an informal Network of European regulators and authorities concerned with the implementation and enforcement of environmental law. The Network's objective is to create the necessary impetus in the European Community to make progress on ensuring a more effective application of environmental legislation. The core of the IMPEL activities concerns awareness raising, capacity building and exchange of information and experiences on implementation, enforcement and international enforcement collaboration as well as promoting and supporting the practicability and enforceability of European environmental legislation.

During the previous years IMPEL has developed into a considerable, widely known organisation, being mentioned in a number of EU legislative and policy documents, e.g. the 7th Environment Action Programme and the Recommendation on Minimum Criteria for Environmental Inspections.

The expertise and experience of the participants within IMPEL make the network uniquely qualified to work on both technical and regulatory aspects of EU environmental legislation.

Furthermore, Environment Compliance Assurance Initiative, promoted by the European Commission pose new challenges that need to be investigated, discussed, to find out proposals to fulfill the ambitious IMPEL's further evolution perspective.</p> <p>Since 2015 IMPEL organizes every year the <i>Water &amp; Land Conference</i>, in order to growth and strengthen the networking among its members with exchange of experience to foster development of IMPEL activities in the land and water topics. The 2018 <i>Water &amp; Land Conference</i> has also become an useful initiative to discuss and present solution to cope with new IMPEL's Ambitions.</p> <p><i>A Water &amp; Land Expert Team meeting</i> is organized every year as well.</p> <p>The 2018 <i>Water &amp; Land Conference</i> was held on September 27<sup>th</sup> and it was organized inside the <i>IMPEL Conference</i> that took in place in Zwolle (The Netherlands) from September 24<sup>th</sup> to September 28<sup>th</sup>, while the <i>Water &amp; Land Expert Team meeting</i> took place in Heraklion on October 25<sup>th</sup> "back to back" with the <i>Water Crimes project workshop</i>.</p>

## 1. Conference and ET Meeting organization

The Conference aimed at improving understanding of CAP implementation issues from across the EU Member States using in particular the findings of the achieving better compliance in the agricultural sector through networking and partnership working of environmental and agricultural inspectorates project, the Good Practice for Tackling Nitrate Pollution from Farms and Farmsteads project and direct information from MSs. A primary aim and intended outcome of the Conference was building and strengthening the IMPEL network through offering mutual support, training opportunity and exchange of good practice. As every year a *W&L ET meeting* follows the *W&L Conference*; the 2018 *W&L ET meeting* was not “back to back” with the Conference (as previous years) but back to back with the *Water Crimes project workshop*, about a month after the Conference.

The *W&L Conference* and the *W&L ET meeting* first Announcement was officially launched on May 10<sup>th</sup> (in attach), while the call for Participation, call for Abstracts was officially launched on June 1<sup>st</sup> (in attach).
