# **Introduction to IMPEL**

The European Union Network for the Implementation and Enforcement of Environmental Law (IMPEL) is an international non-profit association of the environmental authorities of the European Union (EU) Member States, and of other European authorities, namely from acceding and candidate countries of the EU and European Economic Area (EEA). The association is registered in Belgium and its legal seat is in Brussels, Belgium.

IMPEL was set up in 1992 as an informal Network of European regulators and authorities concerned with the implementation and enforcement of environmental law. The Network's objective is to create the necessary impetus in the European Community to make progress on ensuring a more effective application of environmental legislation. The core of the IMPEL activities concerns awareness raising, capacity building and exchange of information and experiences on implementation, enforcement and international enforcement collaboration, as well as promoting and supporting the practicability and enforceability of European environmental legislation.

During the previous years, IMPEL has developed into a considerable, widely known organisation, being mentioned in a number of EU legislative and policy documents, e.g. the 8th Environment Action Programme that guide European environmental policy until 2030, the EU Action Plan: "Towards a Zero Pollution for Air, Water and Soil" on Flagship 5 and the Recommendation on Minimum Criteria for Environmental Inspections.

The expertise and experience of the participants within IMPEL make the network uniquely qualified to work on both technical and regulatory aspects of EU environmental legislation.

During the conference a number of presentations have been given. The topics of the presentations were based on the needs that were identified during the IMPEL Review Initiative held in August 2024 and presentation from partner organisations that have programmes already in place to support Ukraine.

Based on the discussion during the conference the following conclusions were made:

- 1. To create a network of experts that can support Ukraine through IMPEL's Basecamp
- 2. Establishing Coordination Support Group for Ukraine (CSGU)

#### 1. INTRODUCTION

The main goal of the conference was to identify how IMPEL and her partners can support the State Environmental Inspectorate of Ukraine.

To understand better what the most important issues are and where support could be given, an IRI (IMPEL Review Initiative) has been executed in August 2024 in The Hague. During this IRI the following issues have been identified:

- Reform and transformation process of SEI;
- Improvement of the organisational setting of Sei and coordination with other authorities;
- SEI as a learning organisation;
- The use of General binding rules (GBR) in Ukraine;
- The possibilities for more cost neutral inspection activities;
- The reform of SEI's legal status as law enforcement agency;
- A communication strategy to improve the image of SEI;
- SEI as a data driven organisation;
- To further professionalise SEI's risk assessment method;
- Setting up a strategy for compliance assurance;
- To define outcome driven goals to prioritise the work and allocate staff;
- To increase the sanctions for non-compliances;
- To establish a 24/7 system to react on accidents, incidents and complaints;
- To look for modern technologies to perform inspection tasks;
- To prioritise work based on risk and make use of smart IT solutions to support inspection tasks;
- To consider the role of the inspector in permitting process;
- To reform the authorisation to access facilities or entities by inspectors';
- To execute routine inspections at facilities/entities.

This list above is by no means complete but does give a good direction for support to the state Environmental Inspectorate of Ukraine at this moment.

The conference was kicked off by the Ukraine delegation that demonstrated the current stet of play. IMPEL experts addressed good practices on the issues that are listed above and where identified during the IRI in August 2024. The OECD and Sweden as partner organisation and Member State presented their support programmes for Ukraine. The Environmental Law Institute presented the criminal and financial accountability for wartime environmental damage. See chapter 2 for a brief overview. All presentations can be found in chapter 4. #### What already works:

- Working in projects gives SEI inspectors the chance to learn what is possible
- Advisory from IMPEL in building legislative framework
- Sharing and networking in IMPEL conference are important and gives possibilities to have open and honest conversations
- Meetings are motivators for SEI staff
- It assists the way to become member of the EU
- Role of public in environmental inspections (Institute of public inspectors)
- Criteria for assessing the degree of risk from conducting business activities and determining the frequency of inspections
- Unified form of the Environmental Act on inspections
- ECO threat mobile application to report threats to the environment

#### Suggestions of SEI:

- Establishment IMPEL Support Group for Ukraine (SGU) (IMPEL coordination)
- Develop a funding base for establishment Reform Support Team for SEI

- New projects: Promoting green deal readiness in the Eastern Partnership(1/2024 4/2028)

Session 4: Swedish Environmental Protection Agency: Sweden-Ukraine Institutional Cooperation Project (presented by Annakarin Lindberg and Jenny Hakansson)

• Sweden to support EU accession of Ukraine and strengthen waste management in Ukraine – timeframe 9-2024 to 8-2027.



- Activities within the institutional cooperation are:
  - 1. EU accession process
  - 2. Waste management legislation
  - 3. National waste management plan
- Main partner is ministry of environment in Ukraine but SEI is very important here
- Activities on EU accession chapter 27
  - Preparations for bilateral screening 6-2025
- Waste:
  - o Initial phase: study visit to Sweden and workshops
  - o National waste management plan
  - Waste legislation, policies and guidance
  - Technical and institutional capacity
  - o Control, traceability and waste crime

Session 9 – Environmental Law Institute US) Criminal and Financial Accountability for Wartime Environmental Damage in Ukraine: Opportunities and Challenges (presented by Carl Bruch, Susannah Dibble)

- Environmental damage of dams and other infrastructure, pollution, wildfires and pillage of natural resources
- Possible causes of action in criminal and civil court
- Possible forums are Ukrainian courts, international criminal court, international court of justice, other courts and tribunals and register of damage.
- Call to action to provide technical assistance and capacity building for data collection and processing and share legal and economic expertise on prosecuting.
